Findings: During the inspection, it was determined the hand washing requirements were not being followed by the provider or program staff, in that .after the provider cleaned up the infants vomit she did not wash her



hands. she was in direct contact with bodily fluid and did not wash hands afterwards. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Findings: In review of the program's records, it was determined that the form used to secure the written permission of the parent for a field trip or routine trip was missing the required information listed in number 8 below:

1. Child's name;
2. Date of the trip (field trips only);
3. Destination of the trip;
4. Departure and return time of the trip (field trips only);
5. Signature of the parent/guardian;
6. Date on which the permission was signed;
7. Statement notifying parents how their child will be transported;
8. Other Notification if children will have access to bodies of water eighteen inches or more in depth.
