Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to store alcohol in a space not used by children.

Findings: During the inspection, alcohol was determined to be in a space that was accessible to children while children were present. These items must be removed or stored in space not approved or used for children as required. It was determined that the alcohol that was on the dining room table which was accessible to the children in care due to the gate not being closed in the child care kitchen area and the children in care can also access the dining room area when using the childcare restroom there is no barrier to stop the children in care from going through the providers living room to the dining room. During the inspection the provider did remove the alcohol from the dining room and placed the alcohol in an area inaccessible to the children in care. Submit the program's corrective action plan to verify compliance with this rule.

Findings: During the inspection it was observed that the following equipment was observed to be in need of repair or hazardous to children/the following broken or hazardous furniture, equipment or materials were not removed from the child care area: In the outdoor child care play area during the inspection there was a children's picnic table that was broken and not stable and was hazardous to the children in care. Code: The program is required to meet the health training requirements.

Findings: In review of records, it was determined the CCSM or Substitute CCSM was left alone with children and did not have current valid documentation for training listed in number 10 below:

1. First Aid - expired training
2. First Aid - did not have verification of completion of First Aid training
3. First Aid - documentation did not demonstrate the person who provided the training met the trainer qualifications as stated in the rule
4. CPR - expired training
5. CPR - had not taken CPR training
6. CPR - did not have verification of the completion of CPR training
7. CPR - training taken did not include all age groups the program serves and developmental levels of all children in care
8. CPR - documentation did not demonstrate the person who provided the training met the trainer qualifications as stated in the rule

Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in number 1 below

:

1. No medical was on file for at least one child

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
