During the inspection, it was determined that children were not protected from the following item or condition which may threaten their health, safety, or well being as noted in the following number 9 below:

- 1. Telephone cords;
- 2. Stacked chairs;
- 3. Employee(s) purse(s);
- 4. Diaper bags;
- 5. Television not securely anchored;
- 6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
- 7. Staff member stepped over a barrier/gate while holding a child;
- 8. Chipping or peeling paint;
- 9. Vitamins on the bottom shelf in the cupboard above the counter in the kitchen closest to the sliding door.

- 2. A child swims or plays in water eighteen inches or more in depth;
- 3. A child participates in activities in or on water eighteen inches or more in depth;
- 4. Infants and toddlers use wading pools;
- 5. Written permission was not updated annually for on-going activities.
