Rule: 5101:2-13-11 Fall Zone

Code: The program is required to use fall surface material according to manufacturer's guidelines.

Findings: During the inspection, it was determined the fall surface material was not being used according to manufacturer's guidelines for its use as a fall surface for the play slide in the outdoor area. Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.



### Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-13-11 Outdoor Space

Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number 9 below:

- 1. There was broken glass.
- 2. There were tall weeds.
- 3. There was poison ivy.
- 4. There were tree branches.
- 5. There was mold visible.
- 6. The sandbox was contaminated.
- 7. There were thistles with prickers.
- 8. There were bird droppings.

9. Other : trash including a plastic glove next to the outdoor toys and skirting that had pulled away from the side of the mobile home in the area of the deck assessible from the outdoor play area

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
