Findings: During the inspection, it was determined that the attendance records did not include the required information listed in number 5 below:

3. The assigned group for the child;
4. The child's weekly schedule;
5. The time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program.

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to have a sign posted prohibiting carrying a deadly weapon on the premises.

Submit the program's corrective action plan, which includes copies of verification of training, to verify compliance with the requirements of this rule.

Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.
