Code: The program is required to have all outlets and surge protectors covered.



Findings: During the inspection, it was determined that the top outlet in the family room under the window on the left side of the television did not have childproof receptacle cover. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

#### Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to protect children in care from items and conditions that threaten their health, safety, and well being.

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well being. During the inspection, it was determined that children were not protected from the following items or conditions which may threaten their health, safety, or well being as noted in the following numbers 9 & 10 below:

- 1. Telephone cords;
- 2. Stacked chairs;
- 3. Employee(s) purse(s);
- 4. Diaper bags;
- 5. Television not securely anchored;
- 6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
- 7. Staff member stepped over a barrier/gate while holding a child;
- 8. Chipping or peeling paint;
- 9. Phone charger plugged into wall and unraveled under the side table by the couch in the family room.

10. Sharp/razor lids in the top drawer of the kitchen counter to the right side of the pantry and in the drawer to the left of the pantry (right side of stove).

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

#### Domain: 05 Health & Safety

Rule: 5101:2-13-16 Disaster Plan

Code: The program is required to train child care staff members and employees on the written disaster plan annually and keep written documentation of the training on-site.

Findings: During the inspection, it was determined the program's written disaster plan did not meet the requirement for training child care staff members and employees on the plan annually as noted in number 2 below:



1. Child care staff members and employees were not trained annually.

2. Written documentation of the training was not kept on file. Signature and date of all child care staff members need to be recorded on the written disaster plan.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

### Domain: 06 Program Information

Rule: 5101:2-13-14 Vehicle Inspections

Code: The program is required to complete and document weekly vehicle inspections.

Findings: During the inspection, it was determined that the program had not documented weekly inspections of vehicles used for transporting children. The weekly inspection needs to include the following:

1. A visual inspection of the tires for wear and tire pressure;

- 2. A visual inspection of headlights, taillights, signals, mirrors, wiper blades, and dash gauges;
- 3. An inspection for properly functioning child and driver restraints;
- 4. An inspection for properly functioning doors and windows;
- 5. An inspection for, and cleaning of, debris from the inside of the vehicle;
