During the inspection, it was determined that children were not protected from the following items which may threaten their health, safety, or well being as noted in the following numbers 5 & 12 below:

- 1. Open pull cords that are not closed loop;
- 2. Telephone cords;
- 3. Electrical/Extension cords attached to an object that would likely result in a severe injury if pulled;
- 4. Stacked chairs;
- 5. Employee purse;
- 6. Diaper bags;
- 7. Television not securely anchored;
- 8. Small or lightweight pieces of shelving units are not securely anchored to the wall;
- 9. Staff member stepped over a barrier/gate while holding a child;
- 10. Chipping or peeling paint;
- 11. Emergency exits were blocked by the following furniture: [];
- 12. Other (Electric cords in lower kitchen drawer found within children's reach.)

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
