Findings: During the inspection, it was determined that there was no one per cent or skim cow's milk that is Vitamin A and D fortified for children older than twenty-four months of age. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to have written documentation from a licensed physician if child is to be served something other than the required fluid milk.

Findings: During this inspection, it was observed that there was no documentation from a licensed physician or parent as required by the rule, when children between 12 and 24 months of age were supposed to be served whole homogenized Vitamin D fortified fluid milk and no milk was available. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
