Findings: During the inspection, it was determined the program had not responded to the non-compliances addressed in the inspection report dated 6/16/21. Findings: During the inspection, it was determined that a crib/playpen, assigned to a child, was used for storage. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
