Findings: During this inspection, it was determined that food was not stored in a safe manner in that the refrigerator did not maintain a temperature of 40 degrees Fahrenheit or below. Refrigerator temperature was 54.9 degrees. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The provider and program staff are required to make pools on the premises inaccessible to children.

Findings: During the inspection, it was determined a pool was located on the premises and was accessible to children in care as there was no fence or physical barrier as outlined in rule in that the above ground pool had a height of 24 inches, lacked a fence to separate, and its cover could be moved to provide an opening sufficiently



large enough for an infant to pass through. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
