Rule: 5101:2-13-09 Background Checks

Code: The program is required to have background checks for all staff and residents over 18 years of age.

Finding: In review of staff records, it was determined that background checks were not requested for the person(s) listed on the Employee Record Chart as noted in number(s) below: 1, 2

1. Submitting the JFS 01175 "Request for a Background Check for Child Care" or the OPR generated equivalent to the Department;
2. Submitting fingerprints electronically according to the process established by the BCI.

Rule: 5101:2-13-15 Health Conditions

Code: The program is required to have a completed JFS 1236 "Medical/Physical Care Plan" on file for each health condition for each child.

Finding: In review of records, it was determined the JFS 01236 "Medical/Physical Care Plan" was not [completed in its entirety/signed] for 1 out of 20 on file. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule. Bottom of form not signed by provider.

Domain: 07 Diapering & Infant Care

Rule: 5101:2-13-20 Crib and Playpen Requirements

Code: The program is required to remove objects from cribs/playpens that could block the child.

Finding: During the inspection, it was determined that in the playpen was the following number(s) 1 below which could obstruct a provider or child care staff member's view of the infant:

1. Busy box or other toy attached to the side of the crib or playpen.
2. A blanket hanging over the side of the crib or playpen.
3. Stuffed animal that is not large/soft enough that it could conform to the shape of the child's face.
4. Other- a blanket in the playpen

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Domain: 07 Diapering & Infant Care

Rule: 5101:2-13-23 Infant Bottle and Food Preparation

Code: The program staff is required to have all bottles labeled.

Finding: During the inspection, it was determined that bottles for a particular infant were not labeled with the child's name and date of preparation. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-08 Staff Records

Code: The program is required to include days and hours worked, duties, and group assignments in each staff file.

Finding: During the inspection it was determined that employee records did not include days and hours worked, duties and group assignments. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to maintain a file for each staff member at the program.

Finding: During the inspection, it was determined that documentation was not on file at the program to meet the requirements of this rule for the employee(s), as noted on the Employee Record Chart. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-10 Health Training B

Code: The program is required to meet the health training requirements.

Finding: In review of records, it was determined the provider did not have a current certification in First Aid/CPR. Correct the violation and submit the documentation of current certification with the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program staff is required to have educational verification on file.

Finding: In review of the staff records, it was determined that verification of a high school education was not on file for Child Care Staff Member(s) listed on the Employee Record Chart, as required. Submit the program's corrective action plan, which includes a copy of the verification of a high school education, to verify compliance with the requirements of this rule.

Finding: In review of the staff records, it was determined that the provider, administrator, or an individual did not complete requirements of this rule as noted in number(s) 1 below:

1. Individuals employed after October 29, 2017, did not create a profile in the OPR;
2. Individuals employed prior to October 29, 2017 did not create a profile in the OPR by January 1, 2018;
3. Individuals employed prior to October 29, 2017 did not submit the JFS 01175 "Request for a Background Check for Child Care" to ODJFS.

Submit the program's corrective action plan, which includes a statement the individual(s) have created a profile in the OPR, and/or the individual(s) have submitted the JFS 01175 to ODJFS, to verify compliance with the requirements of this rule.

Rule: 5101:2-13-15 Child's Medical

Code: The program is required to have a current medical on file for each child.

Finding: In review of records, it was determined a medical form was not on file/on file within 30 days/updated every thirteen months for 3 out of 20 children. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-15 JFS 01234 'Child Enrollment and Health Information'

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Finding: In review of children's records, it was determined that at least one child listed on the Children's Record Review did not have the JFS 01234 "Child Enrollment and Health Information for Child Care" on file at the program for review. Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-15 JFS 01234 'Child Enrollment and Health Information'

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Finding: In review of the children's records, it was determined that information had not been secured from the parent/guardian on the JFS 01234 "Child Enrollment and Health Information for Child Care," as required, for the items in number(s) 3, 7, 8, 10, 11 below:

1. Complete parent information;
2. Complete emergency contact information;
3. Complete physician information;
4. Information regarding the parent list;
5. Health information;
6. Additional information for all boxes checked "yes";
7. Emergency transportation information;
8. Parent/guardian's signature;
9. Diapering statement;
10. Acknowledgement of policies and procedures;
11. Provider's signature.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.
