Findings: During the inspection, it was determined the program was using space for child care in a manner that was not inspected and approved by the the county agency as noted in number(s) 1 and 2 below:

1. The kitchen was not approved prior to use.

2. The program did not notify the county agency in OCLQS prior to utilizing or structurally modifying any space not previously inspected.
