Findings: During the inspection, it was determined that while there was adequate fall surface material in the outdoor play space, proper distribution had not been maintained under and around equipment as required.

- 3. There was poison ivy.
- 4. There were protruding bolts.
- 5. There were tree branches.
- 6. There was mold visible.
- 7. The sandbox was contaminated.
- 8. There were thistles with prickers.
- 9. There were bird droppings.
- 10. Other-plastic bags.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
