Findings: A review of children records indicated that one medical statements was more than thirteen months old. Exam date on medical was more than 13 months old but physician signature was from 9/17/2020. Staff stated they were unaware that exam date was the date that needed to be within 13 months. TA was given to look closely at exam date.
