Findings: It was observed or reported that a child was left unattended inside or outside the facility. The class was in the hallway by the door used for parents to pick up children at the end of the school day. A substitute teacher and the classroom assistant teacher were there with the class. While assistant teacher was standing at the doorway, a child slipped past her unnoticed to the sidewalk outside the building. At the same time, the parent was coming up the walkway finding her child standing outside without an adult. The parent brought the child back up to the building doorway.
