Findings: A child left unattended on a field trip or in a vehicle or, otherwise, transportation policies are not followed. A child rode the bus from home to school. The child did not exit the bus with peers when they arrived at school. At the end of the day, the child was found on the bus, seat belted in his original seat. The child was immediately taken into the school and checked by the nurse. Parents were contacted to pick up the child and notified of the event.
