Rule: Transitional Pandemic Requirements

Code: The program is required to notify ODJFS and the local health department of positive COVID-19 test results for employees and children and ensure the individual follows isolation or quarantine procedures prior to returning to the program.



Findings: During the inspection, it was determined that a child, provider, employee, resident, or child care staff member tested positive for COVID-19 and the program failed to follow the requirement in number 1 below:

1. Notify ODJFS by the next business day in the Ohio Child Licensing and Quality System (OCLQS) as a serious incident.

2. Notify the local health department by the next business day.

3. Ensure that a child, employee or child care staff member completed isolation or quarantine procedures for COVID-19 in coordination with the local health department, or in compliance with the Ohio Department of Health and CDC guidelines, prior to being permitted to return to the program.

4. Ensure that the provider or resident completed isolation or quarantine procedures for COVID-19 in coordination with the local health department, or in compliance with the Ohio Department of Health and CDC guidelines, prior to resuming care.

Submit the program's corrective action plan, which includes a statement that the provider has made the report to the local health department and/or completed the Serious Incident Report in OCLQS, to the Department to verify compliance with the requirements of this rule.
