**Domain: 02 Safe & Sanitary Environment**

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children had access to it as noted in number(s) [ ] below. The potentially hazardous substance or item that posed a risk to children was determined to be accessible to children in 6, 9, 10, and 14.

Rule: 5101:2-13-12 Safe Equipment

Code: The program is required to have appropriate fall surface for indoor equipment.

Findings: The rule requires that indoor swings, slides, climbers, and climbing apparatus shall not be placed over concrete, tile, carpet, or any similarly hard surface and that indoor climbing equipment more than three feet high have landing mats at least one and one-half inches thick. During the inspection, it was determined that this requirement was not met, in that equipment was placed on hard surface. Submit the program's corrective action plan to verify compliance with this rule.

Rule: 5101:2-13-11 Outdoor Equipment

Code: The program is required to have equipment that does not present a safety risk.

Findings: During this inspection, it was observed that utensils and/or dishes were not suitable as noted in the number(s) below: 5

1. Utensils were too large;
2. Cups were too large to hold;
3. Only a fork was provided;
4. Lids were not provided for sippy cups;
5. Other: Sippy cup was not labeled that was in the refrigerator when arrived. Sippy cups around daycare that the children were drinking from were not labeled.

9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
