Rule: 5101:2-12-04 Food License

<u>Code</u>: The program is required to maintain the food service license of any caterer they may utilize.

<u>Finding</u>: During the inspection, it was determined that a copy of the food service license for the catering food service was not on file at the program. Submit the program's corrective action plan, which includes a copy of the caterer's current food service license, to the Department to verify compliance with the requirements of this rule.

Rule: 5101:2-12-20 Cots and Napping

<u>Code</u>: The program is required to provide cots/mats that are the appropriate dimensions for children in care.

<u>Finding</u>: During the inspection, it was determined that all cots and/or mats did not meet the dimensions as noted in number 3 below:

- 1. The cot must stand at least 3" but no more than 18" off the floor;
- 2. The cot must be at least 36" in length and as long as the child is tall;
- 3. The mat must be at least 1" thick and as wide and long as the child assigned.

<u>Finding</u>: During the inspection, it was determined that at least one piece of equipment, furnishings, or material at the program was not constructed of materials to facilitate cleaning and sanitizing as noted in number 4 below:

- 1. The material had a tear;
- 2. The material was not washable;
- 3. The material was porous;
- 4. The surface was cracked;
- 5. The surface was repaired, but in a manner that still did not facilitate cleaning and sanitizing;

Equipment, furnishings, and furniture shall be constructed of materials to facilitate cleaning and shall be kept clean and in good repair. <u>Finding</u>: During the inspection, it was determined that the children's individual blankets and belongings were stored in an unsanitary manner. Children's belongings need to be stored in a sanitary manner to prevent the spread of germs. - 8. Medical(s) were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases required by division 5104.014 of the Revised Code and found in appendix A to this rule
- 9. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
