Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector in the basement of the home. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
