Rule: 5101:2-12-19 Supervision

Code: The program staff is required to supervise children in their assigned group by sight and hearing. Supervision includes being near enough to respond and reach children immediately and protecting them from harm.

Findings: During the inspection, it was determined that children were left unattended while inside the program as noted in number 2 below:

1. Child(ren) were left unattended once.
2. Child(ren) were left unattended more than once (the Infant room teacher left the infants alone to answer the door & a preschool student was placed on their cot in the hallway outside of the classroom without a child care staff member).



3. Child(ren) left the group and were unattended.
4. Child care staff were using a baby monitor to supervise children.
5. Child care staff were using a walkie talkie to supervise children.
6. Child care staff were using mirrors to view children in another room.
7. Child care staff were using a video camera instead of physically being present in the room.

Children must be supervised and within sight and hearing of a child care staff member at all times. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Code: The program is required to have child sleep only on cots/mats.

Findings: During the inspection, it was determined that a child was sleeping as noted in numbers 1 & 4 below:

1. On the floor;
2. At the table;
3. On a bean bag chair;
4. On a couch or chair;
5. Other [].

Children shall be provided an individually assigned cot or mat to rest, nap, or sleep. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
