**Finding:** During the inspection, it was determined that the following equipment was unclean or soiled during daily use; dramatic play equipment in Preschool 1, barn rug in Toddler 1, dramatic play baby crib, television counter in Schoolage. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.

#### Domain: 04 Indoor/Outdoor Space

**Rule:** 5101:2-12-11 Outdoor Space Requirements

**Code:** The program is required to have an outdoor play space free from general hazards.

**Finding:** During the inspection, it was determined that hazardous conditions existed in the outdoor play area, as noted in number 10 below:

1. There was broken glass.
2. There were tall weeds.
3. There was poison ivy.
4. There were tree branches.
5. There was mold visible.
6. There were thistles with pricklers.
7. There were bird droppings.
8. There were bolts with more than two threads exposed along a fence line or gate on a playground.



9. The sandbox was contaminated.  
 10. Other: the wood and deck drain cover had splintered wood; the mulch border on the Toddler playground next to the sidewalk had rough, splintered edges.
