Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to direct handles of pots and pans inward to make inaccessible to children.

Findings: During the inspection, it was determined the handles of the pots or pans on the stove were not directed inward and inaccessible to children in care. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-13 Clean Environment and Equipment Code: The program is required to wash all furniture weekly or when soiled.

Findings: During the inspection, it was determined the following equipment, as noted in number(s) 10 below, was not being cleaned with soap and water and/or sanitized monthly, as required.

- 1. Cribs.
- 2. Dress-up clothes and hats.
- 3. Washable toys and equipment
- 4. Other No cleaning schedule posted.

Furniture, material and equipment must e maintained according to the cleaning an sanitizing schedule in Appendix A to this rule. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-16 First Aid Kit

Code: The program is required to meet the requirements for first aid kits.

Findings: During the inspection, it was determined that the program did not have a first aid kit [onsite/ on the vehicle/ on a field trip] as required, that included all items listed in the appendix A of the rule. The kit(s) were missing the item(s) or the item(s) were not replaced after use, when expired or damaged listed in number(s) 8 below:

- 1. One roll of hypoallergenic first-aid tape;
- 2. Individually wrapped sterile gauze
- squares in assorted sizes;
- 3. Sterile adhesive bandages in assorted sizes;
- 4.Tweezers;
- 5. Gauze rolled bandage;
- 6. Triangular bandage;
- 7. Rounded end scissors;

8. Tooth preservation system or fresh chilled liquid milk in which to transport a lost permanent tooth, including a written reference indicating location of the refrigerator/freezer where milk is stored if a tooth preservation system is not part of the first aid kit (for programs serving school age children only);

9. A working digital thermometer;

10. Disposable non-latex gloves;

11. A working flashlight;



12. An instant cold pack that has not been activated or ice, including a written reference indicating location of the refrigerator/freezer where the ice is stored if an instant cold pack is not part of the first aid kit;

13. Sealable leak-proof plastic bags in assorted sizes or double bagged plastic bags that can be securely tied for materials soiled with blood or bodily fluids;

14. Pocket mask or face shield, appropriate; for all ages of children in care, for cardiopulmonary resuscitation (CPR) administration;

15. Soap or waterless sanitizer (field trip or transporting away from the program only);

16. Bottled water (field trip or transporting away from the program only).

Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.
