Rule: 5101:2-13-11 Outdoor Space

Code: The program is required to use an outdoor space that is protected from traffic and other hazards with a barrier.

Findings: During the inspection, it was determined that an area was used which was not protected from hazards by a fence in good repair, or other barrier. Although the fence or natural barrier was not meeting the rule



requirements, it was determined to not present an immediate risk for a child to be able to leave the playground. The fence or gate was not in good repair as noted in number(s) 1 below:

- 1. The fencing had a loose slat board from the bottom.
- 2. The fencing was broken.
- 3. The fencing was loose.
- 4. The fencing was rotting.
- 5. The gate was broken and did not close.
- 6. The gate was padlocked.
- 7. The latch on the gate was broken.
- 8. The latch was easily opened by children on the playground.
- 9. The gate had no latch.
