Code: The program is required to meet all requirements for carbon monoxide detectors.

Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector [in the building/on each floor where care is provided] or carbon monoxide detector(s) were not maintained in accordance with manufacturer's recommendations. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Submit the program's corrective action plan to verify compliance with this rule.

Code: The program is required to maintain smoke detectors in the appropriate areas of the program building.



Findings: During the inspection, it was determined the following space did not contain a working smoke detector basement. Obtain a smoke detector and submit the purchase receipt as part of the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to provide notification to parents if smoking occurs on the premises outside of operating hours.

Findings: During the inspection, it was determined that smoking had occurred in the program building or vehicle during hours the program was not in operation; however, parents had not been given written notice of this. Correct the violation and submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to have a completed medical on file for each child.

Findings: In review of of the children's records, it was determined that completed medical statements were not on file, as required, for children listed on the JFS Children's Record Review For Child Care as indicated in number 1 below:
