Finding: During the inspection, it was determined that children were not supervised while outside the program as noted in number 1 below:

1. A child was left unattended outside the facility building (The Preschool classroom came inside from the playground & when doing a head count they discovered a child was missing. The teacher went to retrieve the child immediately upon discovery of the missing child).
2. Child(ren) were left unattended outside the facility building more than once.
3. Child(ren) were left unattended off the program’s premises.
4. Child(ren) were left unattended during a swimming activity.
5. Other [ ].

Children must be supervised and within sight and hearing of a child care staff member at all times. Provide staff training. Submit the program’s corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
