Findings: During the inspection, it was determined that a preschooler was outdoors without the provider. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to meet all requirements for carbon monoxide detectors.

Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector on each floor where care is provided. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations.
