Findings: During the inspection, it was determined that the sandbox on the outdoor play space did not have a lid or other covering. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Findings: During the inspection, it was determined that outdoor play equipment was unsafe as noted in the number(s) 9 below:

- 1. There was rust exposed.
- 2. There were protruding bolts.
- 3. There was cracks.
- 4. There were holes.
- 5. There was splintering wood.
- 6. There were sharp edges or points.
- 7. There were toxic substances.
- 8. There were tripping hazards.
- 9. Other A seat was missing on the swing set that children utilize for play.

Findings: During the inspection, it was determined that there was equipment that presented a safety risk as noted with the number 11 below:

- 1. Rust exposed;
- 2. Protruding bolts;
- 3. Cracks;
- 4. Holes;
- 5. Splintering wood;
- 6. Sharp edges or points;
- 7. Lead hazards;
- 8. Toxic substances;

11. Other - A metal container used for burning wood was rusty and full of water and located in the children's play area.

Code: The program is required to use an outdoor space that is protected from traffic and other hazards with a barrier.

Findings: During the inspection, it was determined that an area was used which was not protected from traffic and other hazards by a fence in good repair, or other barrier. Although the fence or natural barrier was not meeting the rule requirements, it was determined to not present an immediate risk for a child to be able to leave the playground. The fence or gate was not in good repair and/or being used inappropriately as noted in number(s) [] below: Space being used for outdoor play did not have a barrier in place to keep children from wondering outside of the designated play area(s).

- 1. The fencing had missing slat boards.
- 2. The fencing was broken.
- 3. The fencing was loose.
- 4. The fencing was rotting.
- 5. The gate was broken and did not close.
- 6. The gate was padlocked.
- 7. The latch on the gate was broken.
- 8. The latch was easily opened by children on the playground.
- 9. The gate had no latch.
