Domain: 00 License & Approvals

Rule: 5101:2-13-04 Fire Inspection for Type A Homes

Code: The program is required to have fire approval for areas used for child care before using the space.

Findings: During the inspection, it was determined the program had not obtained written approval from the local fire safety inspector or the state fire marshal as noted in number(s) 1 below:

1. The program had not been inspected and approved within 12 months from the date of the last fire approval and the request for the new inspection was not made at least 30 days prior to the expiration of the previous approval.

2. The fire approval had not been obtained due to violations which required re-inspection. The fire inspection had occurred more than 30 days ago, and the program has not corrected the violations and/or scheduled a re-inspection with the fire inspector.

3. The [] space was being used and had not been approved by the fire department or the state fire marshal's office for child care.

Findings: During the inspection, it was determined that children were left unattended and not supervised, in that children were left outside unattended while staff member came inside. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Code: The program is required to have an adequate fall surface on the outdoor playground.

Findings: "During the inspection, it was determined that the playground did not have adequate fall surface under and around equipment as noted in the following number(s) 3 below:

1. No fall surface

2. Adequate fall surface to soften the impact of a fall

3. Other little tykes slide was in the grass without fall zone and fall zone underneath of playhouse was rotted out.

Any equipment designed for climbing, swinging, bouncing, or sliding needs a fall zone of protective material resilient under and around the equipment in order to protect children in the event of a fall. Submit the program's corrective action plan, which includes written verification of the discontinued use of this equipment until corrections are made along with a description of the resilient material added, to the Department to verify compliance with the requirements of this rule."

Rule: 5101:2-13-20 Crib and Playpen Requirements Code: The program staff is required to place infants in a crib or playpen to sleep unless a JFS 01235 "Sleep Position Waiver Statement for Child Care" is on file.

Findings: During the inspection, it was determined an infant slept in equipment other than their crib and did not have written permission from a physician on file. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-24 Parent Permission for Swimming Code: The program is required to have written parental permission before a swimming activity.

Findings: In the review of the program's records, it was determined that the swimming permission form did not include the required information as indicated in the number(s) 3 below:

- 1. The child's name and date of birth;
- 2. Statement indicating whether the child is a non-swimmer or capable of swimming;
- 3. Location of the water activities or swimming site by water of eighteen or more inches in depth;

4. A statement of whether or not the program is providing additional adults or child care staff members above the licensing ratio requirements for this activity;

5. A signature and date from the parent indicating permission for the activity.

Submit the program's corrective action plan to verify compliance with the requirements of this rule.
