This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Findings: During the inspection, it was determined that unsanitary conditions, as noted in the following number(s) 4,5 below, were in the upstairs restroom:

- 1. There was no liquid soap.
- 2. There was no toilet tissue.
- 3. There were no individually assigned towels or disposable towels.
- 4. The toilet cleaning brush was accessible to the children.
- 5. The plunger was accessible to the children.
- 6. The toilet was not flushed.
- 7. The trash was not emptied from the day before.
- 8. There was a strong urine odor.
