Findings: During this inspection, it was determined that food was not stored in a safe manner in that the refrigerator did not maintain a temperature of 40 degrees Fahrenheit or below/milk was not refrigerated for approximately () minutes after being served/food was observed thawing on the counter. The refrigerator was at 43 degrees at the time of inspection. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
