Findings: During the inspection, it was determined that, on the date specified in the allegation, required staff/child ratios were not maintained for different groups, as noted below:

The ratio determined for the infant group was 1 Child Care Staff Member(s) for 8 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 15 children was determined for the preschool group.



Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Findings: During the inspection, it was determined that, on the date specified in the allegation, groups which included children less than two and one half years were combined with groups of children two and one half years and older and there were more than 12 children in the center.
