Findings: During the inspection, it was determined children were not supervised as noted in number 2 below:

1. The provider or child care staff member did not remain awake until all children were asleep.
2. A monitoring device was not used or operable.
3. Children under the age of five did not sleep on the same floor as the child care staff member.

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.



Findings: During the inspection, it was determined the water temperature was 140 degrees in the following room: kitchen. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit.
