2. Play pens;
3. Bassinets;

5. Car seats;
6. Infant swing;
7. The floor;
8. Infant seats;
9. An infant placed in a car seat in a crib;

Infants must be provided with a crib, which meets requirements specified in this rule, for resting and sleeping. Provide staff training.
