1. No attendance record was being maintained.
2. The attendance record was not being consistently completed.
3. The record did not include the name of at least one child.
4. The record did not include the birth date of at least one child.
5. The record did not include the assigned group.
6. The record did not include the child's weekly schedule.
7. The record did not include the time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program. Arrival not marked for one child.
8. The original attendance record was not kept at the program for a period of one year.

1. The JFS 01236 had not been updated as needed . RX label expired 9-5-2025. No Box 2 completed by physician , no attached signed treatment plan.
2. A separate JFS 01236 had not been used for each condition.
3. The program used an old version of the JFS 01236.
