Rule: 5101:2-12-12 Safe Environment

1. There was no liquid soap.
2. There was no toilet paper.
3. There were no paper towels.
4. The toilet cleaning brush was accessible to the children.
5. The plunger was accessible to the children.
6. The toilet(s) were not flushed.
7. The trash was not emptied from the day before.
8. There was a strong urine odor.
9. Other.

The restroom(s) must be kept sanitary at all times. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.

Code: The program is required to provide a sturdy platform for children if the sink or toilet are too high.

Finding: During the inspection, it was determined the platforms for the sink/toilet in the J classroom and hallway bathroom were unsafe for children as noted in number 3 below.

1. No platform was provided.
2. The platform was not sturdy.
3. The platform posed a safety hazard in that it did not have a non-skid bottom surface.
