Code: The program staff is required to place infants in a crib or playpen to sleep unless a JFS 01235 "Sleep Position Waiver Statement for Child Care" is on file.

Allegation: A 7-week old infant was observed sleeping in bouncy seat covered with a fleece blanket, placed in a porta crib.

Determination: Substantiated

Findings: During the inspection, it was determined an infant slept in equipment other than their crib or playpen and did not have written permission from a physician on file. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-20 Crib and Playpen Requirements

Code: The program is required to refrain from placing blankets in cribs with children under 12 months of age and using bumper pads.

Allegation: A 7-week old infant was observed sleeping in bouncy seat covered with a fleece blanket, placed in a porta crib.

Hazardous Object  
No Sleep Position Waiver

Determination: Substantiated

Findings: During the inspection, it was determined that an infant, under 12 months of age, was placed in a crib with a blanket which created a hazard. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
