Code: The program staff shall use developmentally appropriate techniques when managing children's behavior. Corporal punishment is prohibited, as well as any cruel, harsh, unusual or extreme techniques.

Allegation: A child care staff member uses a tone and words that are inappropriate.

Determination: Substantiated

Findings: During the inspection, it was determined through staff interviews that a child care staff member used a discipline technique to guide or discipline children that was not developmentally appropriate, in that the tone and words used were not always appropriate for the situation.

Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
