During the inspection, it was determined the program did not protect children from an unsafe item, condition or equipment noted in number(s) 7 below, in that in the hall to the right of the classroom entrance an exposed electrical box with live wires showing were observed to be accessible to children. The children use this hallway to go to the upper level gym:

- 2. Extension cord(s); electrical cord(s) attached to an object that could result in a severe injury if pulled.
- 3. Stacked tables.
- 4. Folding tables.
- 5. Matches and/or a lighter.

- 7. Live wires.

- 8. Stove(s) that are either on or able to be turned on by a child.
- 9. Asbestos.
- 10. Traffic.
- 11. A body of water.
- 12. A well.
- 13. Environmental hazard(s) confirmed by local authorities having jurisdiction over the hazard.
- 14. A crockpot used to heat bottles.
- 15. Immediate access to a knife.
- 16. Large or heavy pieces of shelving units are not securely anchored to the wall.
