Finding: During the inspection, it was determined that a medication, Albuterol inhaler, was within the reach of children in the school age room, in that the medication was stored in the front pocket of the first aid kit, which was laying on the table, accessible to children. All medications must be stored out of the reach of children. Create procedures that assure medications will always be inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
