<u>Finding</u>: During the inspection, it was determined that the program had an area rug that did not have a nonskid backing, in that the bathroom rugs (Toddler 1, Toddler 2, Preschool 1 & Preschool 2)did not have non-skid backing. A walking surface that is not hazardous to children must be maintained at the program. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.
