Findings: During the inspection, it was determined the administrator, child care staff, and/or employees of the program did not protect or remove children from a situation and/or person determined to be unsafe or inappropriate as noted in number 4 below:

1. Verbal argument involving adults.
2. Staff member(s) allowed child(ren) to do something unsafe.
3. Staff member(s) did something unsafe.
4. Children were exposed to inappropriate behavior by a child. Children were not protected from a child who is often physically aggressive towards other children by hitting them, biting them and pushing them. While none of the incidents required the children to seek medical attention, first aid was necessary on several occasions.
