<u>Finding</u>: During the inspection, it was determined that an older infant was served dried cranberries as an applesauce alternative, which posed a choking hazard and was not appropriate for their age. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is required at this time.
