A walking surface that is not hazardous to children must be maintained at the program. <u>Code</u>: The program staff is required to follow diaper changing procedures.

<u>Finding</u>: During this inspection, it was determined that proper diaper changing procedures were not followed as the teacher did not use the foot pedal to open the trash can to dispose of dirty diapers. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance.
