- d. Written statement, signed by a representative of the TB control unit, that the employee's TB is no longer infectious or the individual is receiving a TB treatment regimen for employees with a positive TB test.

- 5. The substitute(s) had been used more than ninety days annually between July first and June thirtieth and had not completed at least six hours of professional development

- 1. First Aid child care staff members scheduled during the hours of 5:00 and 6:00 had expired training
- 2. First Aid child care staff members scheduled during the hours of and did not have verification of completion of First Aid
- 3. First Aid trained child care staff member was not present in each building used by the program.
- 4. CPR child care staff members scheduled during the hours of 5:00 and 6:00 had expired training

- 5. CPR child care staff scheduled during the hours of [] and [] had did not have verification of completion of CPR

- 10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of

conscience, including religious convictions
