Finding: During the inspection, it was determined that a medication, Epi-pen was within the reach of children in the HD Pre K room, in that the Epi-pen was stored in the front pocket of a book bag which was in a child's cubby. All medications must be stored out of the reach of children. Create procedures that assure medications will always be inaccessible to children. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
