Finding: During the inspection, it was determined that the written record used to document infant routines and activities did not meet the requirements as noted in number 6 below:

1. A daily written record was not provided to the parent or person picking up the infant on a daily basis.
2. Food intake was missing.
3. Sleeping patterns was missing.
4. Times and results of diaper changes was missing.
5. Information about daily activities was missing.
6. The daily record had not been completed for any infants during the inspection.
