The ratio determined for the Infant group was 1 Child Care Staff Member(s) for 6 children. Additionally, a ratio of 2 Child Care Staff Member(s) for 16 children was determined for the Toddler 2 & Get Set group and a ratio of 1 Child Care Staff Member for 16 children was determined for the Pre-K 2 group.



Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
