Findings: During the inspection, it was determined that the program's weekly menu did not meet the requirement as noted in number 7 below.

1. The menu was not posted.
2. The posted menu was not in a visible place readily accessible to parents.
3. The menu was not currently dated.
4. The entire menu was substituted.
5. At least one item on menu did not match what was served.
6. The meal or snack served did not match the posted menu.
7. Substitutions were not recorded on the menu early in the day.
