3. Washable toys and equipment;- Toys baskets in the Toddler 1 room were observed soiled

Finding: During the inspection, it was determined that the following unsanitary conditions were at the program: the cold air vents were observed soiled with thick dust in the school age room. A clean and healthy environment, including furniture, materials and equipment must be provided, and the program shall be cleaned daily.

Finding: During the inspection, it was determined that the program did not implement safe food handling when serving food as noted in number(s) 1 below:

1. Food was served on bare tables for the Toddler 1 group.
2. Food was served directly on highchair trays, and the trays were not removed, cleaned, and sanitized between use for the [] group.

Rule: 5101:2-12-10 Health Training Requirements

Code: The program is required to have all child care staff members complete training in child abuse and neglect recognition and prevention within sixty days of hire. Staff must complete training in first aid and CPR within the first ninety days of hire.

Finding: In review of the staff records, it was determined that at least one child care staff member had not completed required health and safety training as noted in number(s) 2,4 below:

1. Child abuse and neglect recognition and prevention training was not completed within sixty days of hire.
2. First aid training was not completed within ninety days of hire.
3. Cardiopulmonary resuscitation (CPR) training was not completed within ninety days of hire.
4. The child abuse and neglect recognition and prevention training was expired.
5. The first aid training was expired.
6. The CPR training was expired.
